2. Ms. D. Borah, the learned Standing Counsel appears on behalf of the respondent Nos. 1 to 3 and Mr. S.R. Baruah, the learned Government Advocate appears on behalf of the respondent Nos. 4 to 6 and accepts notice.

3. Extra copies of the writ petition be served upon them by 25.11.2025.

4. The case of the petitioner herein is that his father expired on 01.08.1994 at his residence and the cremation was done by the villagers. On account of mutation, partition as well as various other reasons, the petitioner filed an online application dated 20.06.2025 for issuance of a delayed death certificate of his father and also submitted a representation to the District

Commissioner, Kamrup (M) on 23.07.2025. However, the application has not been processed on the ground that the petitioner has not been able to provide a death certificate issued by a doctor. It is under such circumstances, the petitioner is before this Court.

5. The respondents are directed to bring on record their stand by filing affidavits on or before 05.01.2026.
