ORDER

Heard Shri A. Ganguly, learned counsel for the petitioner, who has referred to the order dated 28.05.2025 of the learned Lawazima Court directing the petitioner to take fresh steps for service of notice upon the respondent no. 5 by registered post with A/D as well as by usual method. Also heard Shri R. Talukdar, learned State Counsel.

Shri Ganguly, the learned counsel has submitted that apart from the aforesaid modes, he may be allowed to take steps by *dasti* as there is urgency in the matter.

Considering the submissions, the petitioner is allowed to take steps by *dasti* also apart from the modes indicated by the learned Lawazima Court in the order dated 28.05.2025. Such *dasti* service is to be routed through the Registry of this Court and in the notice accompanying the *dasti*, the next date is to be clearly reflected which is fixed on 23.06.2025.

Prior to the next date, the petitioner is required to file an affidavit in proof of such *dasti* service. By the next date, the official respondents may file affidavit.
