Issue notice making it returnable on 22.04.2026.

2. Mr. S. S. Roy, the learned counsel accepts notice on behalf of the respondent Nos.1, 3, 4, 6 & 7; Mr. A. Bhattacharyya, the learned counsel accepts notice on behalf of the respondent No.2 and Mr. A. Chaliha, the learned counsel accepts notice on behalf of the respondent No.5. Extra copies of the writ petition be served upon them by tomorrow, i.e. 19.02.2026.

3. This is the second round of litigation which the petitioners are constrained to approach this Court.

4. It is the case of the petitioners herein that the petitioners' names were included in the list prepared by the Circle Officer, Bilasipara Revenue Circle in connection with the then rehabilitation policy of the Government of Assam. The petitioners having not been afforded the rehabilitation packages as per the then existing policy, had approached this Court by filing a writ petition which was registered and numbered as WP(C) No.1997/2022. It is pertinent to observe that this Court, by an order dated 21.07.2023, disposed of the said writ petition with

certain directions. Paragraph Nos.5 to 11 of the said order being relevant is reproduced herein under:-

“5. This Court is of the opinion that if the petitioners herein are erosion affected persons and come within the ambit of the Rehabilitation Policy of the Government of Assam, they would be entitled to the benefits of the said Rehabilitation Policy as stipulated in the notification dated 06.01.2021.

6. Mr. S. Baruah, the learned counsel appearing on behalf of the respondents submits that he has no instructions at present as to whether the Circle Officer, Bilasipara Revenue Circle had, in the meantime, submitted the report.

7. Be that as it may, if no report has been submitted, the report is required to be submitted within 1 (one) month by the Circle Officer, Bilasipara Revenue Circle so that the District Level Committee can take a decision as regards the entitlement of the petitioners in terms with the notification dated 06.01.2021.

8. Taking into account the above, this Court, therefore, disposes of the instant writ petition thereby directing the Circle Officer, Bilasipara Revenue Circle to submit the report within a period of 1 (one) months from today, if not already submitted in terms with the communications dated 13.04.2022 and 29.12.2022 issued by the District Level Committee. This Court further directs the District Level Committee upon receipt of the report to decide the entitlement of the petitioners in terms with the Rehabilitation Policy dated 06.01.2021. The District Level Committee shall do so within a period

of one month from the date of receipt of the report from the Circle Officer concerned.

9. It is further directed that if the petitioners have been found to be entitled to upon making necessary verification by the District Level Committee, the said amount be released to the petitioners within a period of 3 (three) months thereafter.

10. The Registry shall furnish a copy of the instant order to Mr. S. Baruah, the learned counsel appearing on behalf of the respondents for affective compliance.

11. The petitioners are further directed to serve a copy of the instant order upon the Circle Officer, Bilasipara Revenue Circle forthwith."

5. It further appears that in pursuance to the order passed by this Court on 21.07.2023, a meeting of the District Level Selection Committee was held on 05.09.2023, wherein it was minuted that the Additional District Commissioner (DM), Dhubri was to put a proposal for financial assistance to the erosion-affected families of Bilasipara Revenue Circle in respect to the flood of 2019 under the Rehabilitation Policy of Erosion Affected Families of Assam, 2020 on receipt of approved copies of the beneficiary list. It further appears that the approved copy of the beneficiary list was forwarded by the District Commissioner to the Commissioner and Secretary to the Government of Assam, Revenue and Disaster Management Department by the

communication dated 11.10.2023. However, the petitioners were not made any payment.

6. The petitioner had also approached this Court by filing a Contempt Application which was registered and numbered as Cont.Cas(C) No.422/2024. However, the said Contempt Application was closed on account of lack of proper pleadings. It is under such circumstances the petitioners have therefore approached this Court by filing the instant writ petition seeking appropriate directions upon the respondent authorities to release/disburse their entitlement as per the Rehabilitation Policy for Erosion Affected Families of Assam, 2020.

7. Mr. A. Bhattacharyya, the learned counsel appearing on behalf of the respondent Revenue and Disaster Management Department submitted that in the meantime, by a notification dated 18.11.2023, the Rehabilitation Policy of Erosion Affected Families of Assam, 2020 has been rescinded and the Government was in proposing to frame a new rehabilitation policy for the erosion affected families after approaching the Government of India for issuance of necessary guidelines. In that regard, he has placed before this Court the notification dated 18.11.2023, which is kept on record and marked with the letter 'X'.

8. From a perusal of the said notification, it is seen that the

said notification would only apply prospectively. Further to that, it is also seen that the Government of Assam has not changed its policy thereby deciding not to grant rehabilitation packages for erosion affected families of Assam. Rather, it appears from the said notification that the Government of Assam is proposing to come up with a new rehabilitation policy for the erosion affected families. Under such circumstances, it is the opinion of this Court that the notification dated 18.11.2023 cannot act as an impediment for the purpose of consideration of the case of the petitioner as to whether the petitioners herein would be entitled to the amounts in terms with the then prevailing Rehabilitation Policy for Erosion Affected Families of Assam.

9. Taking into account that this is the second round of litigation which the petitioners have been constrained to approach this Court, this Court directs the respondents in the Revenue Department to bring on record their instructions by way of affidavit to be filed on or before 20.04.2026 as to why the petitioners herein would not be entitle to the benefit of the Rehabilitation Policy of Erosion Affected Families of Assam, 2020.

10. List accordingly.
