Heard Mr. D. Bhuyan, learned counsel appearing for the petitioner. Also heard Ms. M. Bhattacharjee, learned Addl. Senior Government Advocate for Assam.

Mr. D. Bhuyan, learned counsel has, after making prolonged arguments requested the Court to take up the matter immediately after the ensuing bihu vacations, since he is under instructions that the department may have initiated steps to consider applications of the petitioner.
