Heard learned counsel for the appellant, Ms. P. Borthakur and learned counsel, Mr. A.R. Agarwala for the Nos. 1,2 & 3.

The instant application has been preferred praying for stay of the impugned judgment

and dated 03.04.2025 passed by the learned MACT No.2, KAMRUP(M), in MAC Case No.2157/2022.

2. Learned counsel for the applicant submits that the appellant has filed an appeal against the impugned judgment and dated 03.04.2025, which has been admitted before this Court and it is stated that the applicant has taken good grounds for appeal which is likely to succeed and therefore if the judgment is not stayed during the pendency of the appeal irreparable loss will be caused to the applicants. She has submitted that the applicant is willing to deposit 25% of the awarded amount. Accordingly, the impugned judgment and award dated 03.04.2025 is suspended on the condition that the applicant shall deposit 25% of the awarded amount before the Registry of this Court within 6(six) weeks from today.

3. Upon deposit of the said 25%, the claimant/respondent may be allowed to withdraw the said amount by the Registry upon proper identification and verification by the learned counsel for the respondents.
