Heard Mr. F.A. Laskar, learned counsel for the petitioner. Also heard Ms. P. Das, learned standing counsel, Secondary Education Department, appearing for the respondent Nos.1 and 5 and Ms. K. Phukan, learned Government Advocate, appearing for the respondent Nos.2—4.

The petitioner is aggrieved for non-consideration of his prayer for being appointed on compassionate ground by the District Level Committee, Cachar, in its minutes of meeting dated 16.08.2025 and it appears that the DLC has rejected the proposal of the petitioner as it spent its force as per principle 10 of the O.M. dated 01.06.2015.
