Heard Ms. P Saharia, learned counsel for the petitioner. Also heard Ms. G Hazarika, learned counsel for the respondent No. 1; Mr. A Phukan, learned counsel for the respondent No. 2; Mr. P N Goswami, learned Government Advocate for the respondent Nos. 3 & 4 as well as Mr. K P Pathak, learned counsel for the respondent No. 8.

Ms. P Saharia, learned counsel for the petitioner seeks two week's time to file rejoinder in the matter.

It is observed that on earlier occasion also, i.e., on 20.01.2026, the petitioner sought time to file rejoinder. However, the same has not been filed till dated.

Mr. K P Pathak, learned counsel for the respondent No. 8 contends that in the connected I.A. (Civil) No. 4135/2025, this Court by order dated 18.12.2025 has suspended the order dated 11.12.2025 passed by the Additional District Commissioner, Nagaon, whereby the meeting of the existing trust was called. He accordingly, submits that there is some urgency in the matter, as the affairs of the temple is being affected.

Considering the urgency canvassed by the learned counsel for the respondent No. 8 trustee, the matter stands posted to **24.06.2026**.

It is made clear that if the rejoinder is not filed by the next date of listing, the matter

shall proceed in accordance with law.
