Heard Mr. R. Goswami, learned counsel for the review petitioner.

2] By filing this petition, the review petitioner seeks to review of paragraph 15 of the judgment and order dated 31.10.2025, passed in MAC Appeal No. 178/2014.

2] The paragraph 15 is reproduced herein below:

“15. The insurer of the offending vehicle/ Truck bearing

Registration No. AMS-8731 i.e. United India Insurance Co. Ltd. (respondent No. 6), shall pay the balance amount of compensation after deducting Rs. 2,00,000/- payable by the appellant i.e. National Insurance Company Ltd."

- 3]** The review applicant submits that there is apparent error in the above paragraph 15 of the judgment sought to be reviewed and that the appropriate direction does not correctly reflect finding recorded in the judgment.
- 4]** Issue notice, making it returnable by four weeks.
- 5]** The petitioner shall take steps for service of notice upon the respondent by speed post within three days from today.
- 6]** List the matter after 4 weeks.
