on behalf of the respondent Nos. 1, 2 and 4 to 9 and Mr. A. Chaliha, the learned Standing Counsel, Finance Department appears on behalf of the respondent No. 3 and accepts notice.

3. Extra copies of the writ petition be served upon the respective counsels within 3 (three) days.

The case of the petitioner herein is that the petitioner was allotted the work for "Construction of Circle Office building including Civil, Electrical works and Brick boundary wall with RCC posts in respect of Circle Officer, Lala Revenue Circle under Hailakandi District (Providing external Electrification)". It is the further case of the petitioner that after completion of all the allotted work, the same was duly and properly checked, verified, measured, and the necessary bills were also prepared as the "First and Final Bill," which was passed for payment by the Competent Authority for an amount of Rs. 7,07,955/-, which remains outstanding. Thereafter, on 13.06.2025, the petitioner submitted a representation to the respondent No. 5 seeking payment of the outstanding amount. However, as the said amount has not been paid, the petitioner has approached this Court by filing the present writ petition.

5. The respondents are directed to bring on record their stand by filing the affidavits on or before 16.03.2026.
