Mr. J I Borbhuiya, learned counsel for the petitioner, disputes the computation of arrear salaries of the petitioner, made by the respondent authorities in the matter. He submits that the petitioner in terms of the order dated 28.02.2023 is entitled to receive his pay in the scale authorized to the post of Assistant Conservator of Forests, w.e.f. 27.08.2009. He further submits that the petitioner was promoted vide Notification dated 03.04.2023 to the rank of Deputy Conservator Forests (DCF) with retrospective effect, i.e., w.e.f. 09.10.2014. He submits that the notional benefit required to be extended to the petitioner in the post of DCF w.e.f. 09.10.2014 has not been granted to him.

Mr. R Gogoi, learned Standing counsel, Forest Department submits that he would complete his instructions in the matter and apprise this Court as to whether the computation of pay of the petitioner was done in the above manner.
