Heard Mr. A.M. Barbhuiya, learned counsel for the petitioner. Also heard Mr. P. Borthakur, learned Additional Public Prosecutor for the State.

2. By this petition filed under Section 482 of the Bharatiya Nagarik

Suraksha Sanhita, 2023, the petitioner, namely, **Zakir Hussain Mazumder**, has prayed for granting pre-arrest bail, apprehending arrest in connection with Hailakandi P.S. Case No. 145/2025 under Section 85/3(5) of BNS, 2023.

3. The FIR has been lodged by the informant/wife against her husband who is the petitioner herein and three other members of his family. The allegations are about commission of cruelty and harassment upon her. It is also alleged that her husband is having an illicit relationship with another woman and that is one of the reasons why he is inflicting cruelty upon her.

4. The petitioner is stated to have been married for 16–17 years and to have a 14-year-old child.

5. Call for the case diary.

6. In the given facts and circumstances, I deem it proper that at this stage, the present petitioner can be given a chance to record his statement with some interim protection.

7. Accordingly, in the event of arrest of the accused-petitioner, they shall be released on **interim bail** in connection with Hailakandi P.S. Case No. 145/2025 under Section 85/3(5) of BNS, 2023, on furnishing bail bond of **Rs.25,000/-** with one suitable surety of the like amount to the satisfaction of the arresting authority.

8. The direction for bail is further subject to the condition(s) that the accused-petitioner:

(a) shall render cooperation with the investigation;

(b) shall not hamper or tamper with evidence; and

(c) shall not intimidate or harass the informant or her family

members.

9. Violation or breach of condition(s) shall entail cancellation of the bail.
