Case taken up before the Lawazima Court.

Learned counsel Mr. M. Ali appears on behalf of the petitioner. Heard.

Perused the records.

A perusal of the office note dated 27.08.2026 reveals that notices were issued to the respondent Nos. 6 & 7 by way of speed post with A/D mode on 22.12.2025.

Now, regarding the aforementioned notices issued to the respondent Nos. 6 & 7, it has been observed as follows:–

*(i) In respect of the notice issued to the respondent No. 6, it appears that the neither the A/D card nor any un-served notice has been received by the Registry till date. However, a perusal of the postal track consignment reports **(kept at Flag-'TC' in the Part-III file)***

pertaining to the said notice reveals that the notice was delivered to the respondent No. 6 on 30.12.2025.

*(ii) In respect of the notice issued to the respondent No. 7, it appears that the A/D **(kept at Flag-'AD' in the Part-II file)** has been received and a perusal of said A/D card reveals that it bears the purported signature of the respondent.*

*(iii) Further, it appears that **parawise comments (kept at Flag-'Parawise Comment') have been** received from **Respondent No. 6, 'The Executive Officer, Lanka Municipal Board, Hojai, Assam'.***

In view of the observations made above, it may be said that **service of notice upon the respondent Nos. 6 & 7 has been completed.**

Pursuant to the above, the matter may be placed before the Hon'ble Court.
