Case taken up before the Lawazima Court.

Learned counsel Ms. T. Begum appears on behalf of the petitioner. Heard.

Perused the records.

Perusal of the instant case record reveals that notice was issued to the respondent Nos. 6, 7 & 8 by registered post with A/D on 07.03.2025.

However, in the meantime, it appears that the learned counsels have already entered appearance on behalf of the respondent No. 8 by filing Vakalatnama. As such, it may be said that **service in respect of the respondent No. 8 has been completed.**

Further, in regard to the aforesaid notice issued to the remaining respondents, *i.e., respondent Nos. 6 & 7*, it appears that neither the A/D cards nor the un-served notices have been received by the concerned section as of yet.

However, it has been observed that the postal track consignment reports regarding the aforesaid notice issued to the respondents are available with the case record, which reveals that the notice in respect of the respondent Nos. 6 & 7 has been delivered to the addressees on 13.03.2025. As such, it may be said that **service in respect of the respondent Nos. 6 & 7 has been also completed.**

Furthermore, it may be mentioned that the learned counsels have also entered appearance on behalf of the respondent No. 9 by filing Vakalatnama. As such, it may be said that **service in respect of the respondent No. 9 has been completed as well.**

In view of the above, the matter may be placed before the Hon'ble Court.
