Heard Shri R.J. Das, learned counsel for the petitioner, who is aggrieved by a notice dated 10.12.2025 issued by the Executive Officer, Digboi Municipal Board directing removal of obstructions / encroachment pertaining to a plot of land which has been alleged to have been encroached by the petitioner by constructing footings of boundary walls / pillars.

When this matter had come up for consideration on 12.12.2025, the learned State Counsel was directed to obtain instructions from the concerned Circle Officer, Margherita Revenue Circle.

Ms. M. Barman, learned State Counsel has submitted that written instructions have been received on 16.12.2025. She has submitted that demarcation dates were fixed in which the petitioner chose not to attend.
