ORDER

Heard Mr. S. Ahmed, learned counsel for the petitioners and Mr. B. Sarma, learned Additional Public Prosecutor, for the State.

2. This is an application under Section 482 BNSS, 2023 praying for grant of pre-arrest bail to the accused/petitioners, namely, **(i) Hanif Uddin; (ii) Yahiya Alom; (iii) Ikbal Hussain; (iv) Irafan Ali and (v) Md. Abdul Jalil Majumdar** who are apprehending their arrest in connection with **Kampur P.S. Case No. 150/2025** under Sections 191(2)/126(2)/132/324(4)/121(2)/109(1)/303(2) of the BNS, 2023.

3. Considering the submissions made by the learned counsel for both sides, I find it a fit case to extend the privilege of interim pre-arrest bail to the petitioner No.1, namely **(i) Hanif Uddin**, till receipt of the case diary.

4. However, the prayer for interim pre-arrest bail in respect of petitioners Nos. 2, 3, 4 and 5 is not considered at this stage.

5. Accordingly, it is provided that in the event of arrest of the petitioner No.1, namely, **(i) Hanif Uddin**, in connection with **Kampur P.S. Case No. 150/2025** under Sections 191(2)/126(2)/ 132/324(4)/121(2)/109(1)/303(2) of the BNS, 2023, he shall be enlarged on interim pre-arrest bail on his executing a bail bond of Rs.20,000/- (Rupees Twenty Thousand) only, with one surety of the like amount to the satisfaction of the arresting authority, subject to the following conditions:

(i) that the petitioner shall appear before the

Investigating Officer of the case within a period of 1(one) week from today to enable recording of his statement;

- (ii) that the petitioner shall fully co-operate with the investigation of the case and shall appear before the Investigating Officer as and when required in connection with the investigation of the aforesaid P.S. Case and
- (iii) that the petitioner shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him/her from disclosing such facts to the Court or to any police officer.

6. List the matter, accordingly, on **21.01.2026** for production of the updated case diary.
