ORDER

Heard Mr. A.R Bhuiya, learned counsel for the applicant. Also heard Mr. K.P. Pathak, learned Standing Counsel for the Forest.

This interlocutory application has been filed by the petitioner No. 10 in W.P(C) No. 4258/2025. The cause title of the said writ petition being W.P(C) No. 4258/2025, the name of the petitioner No. 10 was reflected as Ahmed Ali, S/O Umed Ali, Age-65 Years *Vill-Dhupguri*, Dist- Golaghat, Assam.

In the said writ petition, the Co-ordinate Bench had passed an order dated 29.07.2025 whereby while issuing notice, the following orders were passed:

“9. After considering the rival submissions and also keeping in view the submissions made on behalf of the petitioners that 7 days time would be too less, this Court directs that the time to vacate the land in question be extended till 07.08.2025 and till such time, no forceful eviction be carried out. It is however made clear that after the said date i.e. 07.08.2025, the State will be within its bound to take any steps for eviction and conservation of the forest land. It is also made clear that this order would be confined

*only to the present petitioners.
10. List this case after 6(six) weeks."*

The learned counsel for the applicant submits that subsequently it has been noticed that there are some corrections in the particulars of the said petitioner No. 10 namely Ahmed Ali, S/O Umed Ali, Age-65 Years *Vill-Dhupguri*, Dist-Golaghat, Assam and instead of village being reflected as "Dhupguri" it should be reflected as "Gelajan" and P.O-Dhupguri, P.S Uriamghat in the District of Golaghat, Assam.

This error had crept in inadvertently and therefore the applicant seeks liberty from the Court to make necessary correction in the cause title.

Mr. K.P Pathak, learned Standing Counsel, Forest Department does not object to the prayer made.

Accordingly, the interlocutory application stands allowed.

The cause titled be corrected by reflecting the name of the petitioner No. 10 in W.P.(C) No. 4258/2025 as *Ahmed Ali, aged about 65 years, S/O-Umed Ali, Resident of Village: Gelajan, P.O.-Dhupguri, P.S- Uriamghat, District-Golaghat, Assam.*

This order shall be read together with the order dated 29.07.2025 passed in W.P(C) No. 4258/2025.

The applicant will file amended cause title within one week from today.

The interlocutory application stands allowed and disposed of.
