Heard Mr. L.N. Dihingia, learned counsel appearing for the petitioner. Also heard Ms. A. Gayan, learned CGC appearing for all the respondent Nos. 1 to 4.

Petitioner is serving as a Head Constable in Shasastra Seem Bal (SSB) and he is aggrieved for not giving any promotion to the next higher post of Sub-Inspectors in SSB. In that regard petitioner submitted that he joined his service on 04.06.1988 and thereafter he was promoted to the post of Head Constable on 05.07.2010 and the respondents promoted juniors to him who joined in service later than him to the next higher post of Sub Inspectors disregarding his claim. Hence, this writ petition.

Issue notice, returnable by **27.01.2020**.

As Ms. A. Gayan, learned CGC has accepted notice on behalf of the respondent Nos. 1 to 4, no formal notice need to be issued to those respondents.

The petitioner shall serve requisite extra copies of this petition along with the annexures appended thereto to Ms. A. Gayan, within two days from today for her necessary use.

Pendency of this petition shall not be a bar for the respondents to consider the case of the petitioner for his promotion as per his entitlements, if there is no other impediment in giving such benefit to him.
