A perusal of the instant case record reveals that the previous Lawazima Court vide its order dated 03.06.2026 had directed the petitioners to take fresh steps for service of notice upon the respondent Nos. 8, 9, 11, 12, 14, 16, 18, 19, 21, 25, 26 & 27, within ten days from the date of the said order.

However, as of today, no steps for issuance of notice to the aforementioned respondents have been received from the petitioners' side.

In view of the above, the petitioners are afforded further one week time to take fresh steps for service of notice upon the respondent Nos. 8, 9, 11, 12, 14, 16, 18, 19, 21, 25, 26 & 27 via speed post mode ***[in terms of the Notification No. 85 dated 15<sup>th</sup> October, 2025 (at Flag-'N')]***.
