Issue notice making it returnable on 16.03.2026.

2. Mr. N. Goswami, the learned Government Advocate accepts notice on behalf of the Respondent Nos. 1, 3, 4 and 5.
3. As the Respondent Nos. 1, 3, 4 and 5 are duly represented, extra copies of the writ petition be served upon him by 17.02.2026.
4. As regards the Respondent Nos. 2, 6 and 7, the Petitioners are directed to take steps by way of Speed Post by 17.02.2026.
5. In addition to that, the Petitioners are given the liberty to take steps upon the Respondent Nos. 2, 6 and 7 by way of dasti routed through the Registry of this Court and file an affidavit of service on or before the next date.
6. This Court taking into account the manner in which the Respondent No.8 has been arrayed in the instant proceedings is not inclined to issue notice.
7. The case of the Petitioners herein is that the Petitioners along with the Respondent Nos. 6 and 7 are joint owners of a plot of land admeasuring 1 Bigha 8 Lechas covered by Dag No.27 of Patta No.111 of Village Dhemaji Nagar 3 No. Block under Dhemaji Revenue Circle in the District of Dhemaji, Assam.
8. The grievance of the Petitioners herein is that without taking their No Objection, the Respondent Nos. 2 and 3 have constructed a water supply scheme over their land on the basis

of purported agreement entered into with the Respondent No.6. It is under such circumstances, the instant writ petition has been filed.

9. The Respondents herein are directed to bring on record their stand by filing their affidavits on or before 10.03.2026.
