ORDER

Date : 22.04.2026

Case taken up before the Lawazima Court.

None appears on behalf of the petitioners.

Perused the records.

Perusal of the recent office note dated 22.04.2026 reveals that notice was issued to the respondent Nos. 2, 6 & 7 by way of *dasti* mode on 23.02.2026 and by way of speed post mode on 24.02.2026.

Now, in respect of the above mentioned notices issued to the respondents, it has been observed as follows:–

In respect of the notice issued through dasti mode:– *The petitioners have not yet filed any affidavit regarding service of the said dasti notice upon the respondent Nos. 2, 6 & 7.*

In respect of the notice issued through speed post mode:– *In regard to the said notice, it has been observed as follows:–*

Respondent No. 2:– *it appears that that neither the A/D card nor any un-served notice has been received in respect of the notice issued to the respondent No. 2.*

*However, it appears that the postal track consignment report regarding the said notice has been generated and the same has been annexed with the case record at **Flag-'P' in the Part-III file. Now, a perusal of the said postal tracking report reflects that the notice issued to the respondent No. 2 has been delivered to the addressee on 13.03.2026. As such, it may be said that service in respect of the respondent No. 2 has been completed.***

Respondent Nos. 6 & 7:– *In respect of the said respondents, it appears that the notices*

issued to them have been received un-served with the similar postal remarks, which can be read as follows:- **"Addresses not found, no contact no is mentioned. Delivery attempt Fail. Hence, RTS"**.

In view of the above, the petitioners are hereby directed to obtain necessary instructions regarding the addresses of respondent Nos. 6 & 7, within 7(seven) days from the date of this order and submit the same before the next Lawazima Court.

Let the matter be listed again before the Lawazima Court on 06.05.2026.
