Talukdar, learned counsel for the petitioner has referred to the order dated 25.02.2026 and it is pointed out that as per the directions contained in paragraph-6 of the said order, two records were called for. However, the records of FT Case No. 2351/G/10, arising out of (ERO's Case No. 357<sup>91/38</sup>) have been received. However, the proceedings that has been challenged is Case No. FT (G-4) 1016/15 (old)/ FT (G-4) 1016/24 (new) arising out of Ref. FT Case No. 498/2010, which is being assailed on the ground of being barred by *res judicata*, though called for, have not been received.
