Heard Mr. I. Jamir, learned counsel for the applicant. Also heard Mr. L.T. Sangtam, learned Additional AG.

**2.** This interlocutory application is preferred by the applicant for impleadment of the plaintiffs in Declaratory Suit No. 6 of 2005 as well as Declaratory Suit No. 7 of 2005 as respondents in WP(C)/43/2025 directed by this Court vide Order dated 11.12.2025, passed in WP(C)/43/2025.

**3.** The learned counsel for the applicant submits that the Declaratory Suit No. 6 of 2005 was filed before the learned Civil Judge (Senior

Division), Dimapur by one Shri Vilhulie Khate. During the pendency of the suit, said plaintiff expired leaving behind 6 (six) legal representatives namely:

- i. Smt. Virizeno Khate
- ii. Smt. Vithonguno Khate
- iii. Smt. Vishurhono Khate
- iv. Shri Viphituo Khate
- v. Shri Nouneselhu Khate
- vi. Shri Seyievito Khate,

who are to be impleaded as respondents in the WP(C)/43/2025. The learned counsel also submits that Declaratory Suit No. 7 of 2005, was filed before the learned Civil Judge (Senior Division) Dimapur by Angami Women Farming Cooperative Society, Dimapur, Nagaland represented by its President. However, the petitioner has been informed that the nomenclature of "Angami Women Farming Cooperative Society, Dimapur, Nagaland" is now changed to "Kuda Razha Angamimiapfü" and Ms. Cüka Peseyie is the President of the said society. The learned counsel for the applicant further submits that he has given the above mentioned details of the plaintiffs in Declaratory Suit Nos. 6 and 7 of 2005, as mentioned in FA/1/2014, arising out of impugned judgment dated 10.03.2014, passed

in Declaratory Suit Nos. 6 and 7 of 2005; and as such, the applicant may be permitted to place and rely upon a copy of FA/1/2014 at the time of hearing of the petitioner and also for impleading the plaintiffs in Declaratory Suit No. 6 of 2005, as respondents in WP(C)/43/2025.

**4.** The learned Additional AG submits that he has no objection in the event of allowing this interlocutory application.

**5.** Accordingly, taking into account the submissions of the learned counsels of both the parties, and also considering the facts and circumstances on record, this interlocutory application stands allowed. Smt. Virizeno Khate, Smt. Vithonguno Khate, Smt. Vishurhono Khate, Shri Viphituo Khate, Shri Nouneselhu Khate and Shri Seyievito Khate, be impleaded as respondent nos. 3, 4, 5, 6, 7 and 8 in WP(C)/43/2025 and plaintiff in Declaratory Suit No. 7 of 2005, Kuda Razha Angamimiapfü also be impleaded as respondent no. 9 in WP(C)/43/2025.

**7.** In terms of the above, I.A.(Civil)/2/2016 stands disposed of.
