Heard Mr. Manjong Konyak, learned counsel for the applicant.

The learned counsel for the applicant submits that he has filed CrI.P.39(K)2025, seeking quashing and setting aside of the orders, dated 20.05.2024, 27.06.2024, 25.02.2025, 10.04.2025, 28.05.2025, 24.06.2025, 29.08.2025, and 10.10.2025 passed in P.R. C. Case No. 01/2024, by the Judicial Magistrate, 1st Class, Tuensang, Nagaland.

3. The learned counsel submits that inadvertently, the informant was not impleaded as party respondent in the said criminal petition.
