1. Heard learned counsel Mr. A. Sharma for the petitioners. Learned CGC, Mr. Yangerwati is present for respondent Nos. 1 to 4 and learned Additional A. G., Mr. L. D. Sangtam is present for respondent Nos. 5, 6 & 7.
2. The petitioners are before this Court as they have not received interest on the delayed payments for damage compensation assessed and finally paid to them in the year 2024-2025 pertaining to a damage that took place in the year 2012. These damages suffered by the 744 petitioners was as a result of construction of roads in the Phek district from Zunheboto to Chakhabama.
3. The learned counsel for the petitioners has relied on

the decision of the Hon'ble Supreme Court in **Alok Shanker Pandey Vs. The Union of India reported in (2007) 3 SCC 545**, wherein it has been held that:-

*“We are of the opinion that there is no hard-and-fast rule about how much interest should circumstances of each case. We are of the opinion that the grant of interest of Id be granted and it all depends on the facts and 12% per annum is appropriate in the facts of this particular case. However, we are also of the opinion that since interest was not granted to the appellant along with the principal amount, the respondent should then in addition to the interest at the rate of 12% per annum also pay to the appellant interest at the same rate on the aforesaid interest from the date of payment of installments by the appellant to the respondent till the date of refund of this amount, and the entire amount mentioned above must be paid to the appellant within two months from the date of this judgment.*

*It may be mentioned that there is misconception about interest. Interest is not a penalty or punishment at all, but it is the normal accretion on capital. For example if A had to pay B a certain amount, say 10 years ago, but he offers that amount to him today, then he has pocketed the interest on the principal amount. Had A paid that amount to B 10 years ago, B would have invested that amount somewhere and earned interest thereon, but instead of that A has kept that amount with himself and earned interest on it for this period. Hence, equity demands that A should not only pay back the principal amount but also the interest thereon to B.”*

The learned counsel for the petitioners has also relied on the decision of the Hon'ble Supreme Court in **Sunder Vs. The Union of India reported in (2001) 7 SCC 211**, wherein it has been held that:-

*“The proviso to Section 34 of the Act makes the position further clear. The proviso says that "if such compensation" is not paid within one year from the date of taking possession of the land, interest shall stand escalated d to 15% per annum from the date of expiry of the said period of one year "on the amount of compensation or part thereof which has not been paid or*

*deposited before the date of such expiry". It is inconceivable that the solatium amount would attract only the escalated rate of interest from the expiry of one year and that there would be no interest on solatium during the preceding period. What the legislature intended was to make the aggregate amount under Section 23 of the Act to reach the hands of the person as and when the award is passed, at any rate as soon as he is deprived of the possession of his land. Any delay in making payment of the said sum should enable the party to have interest on the said sum until he receives the payment. Splitting up the compensation into different components for the purpose of payment of interest under Section 34 was not in contemplation of the legislature when that section was framed or enacted."*

4. I have considered the submissions at the Bar with circumspection.
5. Issue rule returnable within 4 (four) weeks.
6. Admit this matter.
7. Notices have been accepted on behalf of the respondents and thus no formal notice is required to be issued. Extra copies to be furnished.
