The instant application U/S 12 of the Contempt of Courts Act R/w Article 215 of the Constitution of India has been filed by the petitioner alleging Willful and deliberate non-compliance of the order dated 18.07.2025 passed in WP(C)/337/2022.

Heard learned counsel for the petitioner, Mr. Nocklei M. Konyak.

Learned counsel submits that by the order dated 18.07.2025 in WP(C)/337/2022, this Court had directed the respondent authorities to regularize the petitioner's service, a day before his superannuation, within a period of 4 (four) months from the date of receipt of the copy of the order. It is submitted that the order of this Court was served on the State respondents by the letter dated 24.07.2025, which was received by the respondents on 25.07.2025.

Learned counsel for the petitioner further submits that the State respondents have failed to comply with the directions of this Court even after the expiry of 4 (four) months from the date of the order. Being aggrieved, the petitioner had preferred the present application.

Issue notice, returnable in 4 (four) weeks. The petitioner shall take steps for notice on the respondents by Speed Post document as

well as usual process within 3 (three) working days.
