As prayed for by Mr. Imti Imsong, learned Additional A.G., Nagaland, one week's time is granted to file the Verification Report dated 20.02.2024.

At this stage, Mr. Sentiyanger, learned counsel for NHIDCL submits that NHIDCL may be permitted to file an additional affidavit in view of the submission of the report by the Deputy Commissioner, Kohima.

Considering the fact that this matter has been dragging on for quite some time, this Court, for ends of justice, considers it appropriate to give one last opportunity to the respondents concerned for filing the additional affidavit.

The Deputy Commissioner, Kohima, shall file the Verification Report on or before 02.09.2024. Similarly, NHIDCL shall file the additional affidavit, if so advised, within the same date.

List the matter on **05.09.2024** on which date, an attempt shall be made to dispose of the writ petition.
