In this writ petition, the petitioner is seeking a direction to the State respondents for regularizing of his service as he is eligible for the same in terms of the O.M of the Government issued in the year 2004 as well as in 2015.

The learned Government Advocate Ms. A. Ayemi has submitted that the petitioner has been found eligible for consideration of regularization in terms of the aforesaid O.Ms. She also submits that the matter has already been forwarded to the Government for consideration. However, she is unaware about the present status of the said case she therefore seeks some time to

let this Court know at what stage the matter of regularization of the petitioner is pending before the Government.
