Heard Ms. Z. Zhimomi, learned counsel for the appel-
lants and also heard Mr. C.T. Jamir, learned Sr. Counsel assisted
by Ms. Toshi Jamir, learned counsel for the respondent Nos.6, 8,

9, 10, 12 and 13. None appears for the respondent Nos. 1, 2, 3 and 4.

Office note, dated 27.01.2026, indicates that the appellants have not taken any steps for service of notice upon the respondents.

Mr. C.T. Jamir, learned Sr. Counsel, has pointed out that vide order dated 21.01.2026, while admitting the appeal, this Court had directed the appellants to take steps upon the respondent Nos. 5, 7 and 11 by way of speed post as well as by usual process within three working days, but, the appellants have not taken any steps as per the said order and on account this, this petition is liable to be dismissed.

However, Ms. Z. Zhimomi, learned counsel for the appellants submits that she will take steps upon the respondent Nos. 5, 7 and 11 though inadvertently the appellants could not take steps.

Accordingly, it is provided that Registry shall list the matter after 4(four) weeks and in the meantime, the appellants shall take steps upon the respondent Nos. 5, 7 and 11 pursuant to the direction issued by this Court vide order dated 21.01.2026.
