Heard Mr. C. Zoramchhana, learned counsel for the petitioner. The instant writ petition file under Article 226 of the Constitution of India is with regards to the rejection of the joint representation filed by the petitioners vide letter dated 07.10.2024 rejecting their prayer for up-gradation under the Modified Assured Career Progression Scheme for the Mizoram Govt. Employees , 2020 (MACPS, 2020).

The learned counsel submitted that the petitioners were employed as Muster Roll Employees under the Govt. of Mizoram in P.H.E. and P.W.D. Department and were regularized in 2008. Thereafter, they had enjoyed their first financial upgradation vide Order dated 27.08.2021 under the MACPS 2020. The petitioners had then submitted their representation for counting their past services as Muster Roll employees for the purpose of enjoying the MACPS, 2020 which was rejected by the said Letter dated 07.10.2024 though entitled under the MACPS, 2020. It is also the submission of the learned counsel for the petitioner that other similarly placed persons were granted the upgradation by counting their past services as Muster Roll and thus, they should also be given the same treatment as those persons who are similarly situated.

Issue notice to the respondents.

Ms. Vanneihsiami, learned Govt. Advocate accepts notice on behalf of the

State respondents. No need to issue formal notice. Requisite copies of the writ petition to be duly furnished to the learned Govt. Advocate.
