Ms. Rosalynn L. Hmar, learned counsel appears for the petitioner and Mr. Samuel Vanlalhriata Chhangte, learned counsel appears for respondent No. 1.

Mr. Samuel Vanlalhriata Chhangte, learned counsel submits that in terms of the last Court's Order dated 17.05.2024, the respondent No. 1 has deposited a sum of Rs. 10,000/- as was directed before the Mizoram State Legal Services Authority this morning i.e., 05.06.2024.
