Heard Ms. K. Laltanpuui, learned counsel for the applicant, who submits that there is a delay of 5 days in filing the appeal against the impugned Judgment & Award dated 22.08.2025, passed by the District Judge, Aizawl in Arbitration Case No. 4/2022, arising out of Arbitration Proceeding No. 5/2022.

Mrs. Vanneihsiami, learned Advocate General submits that she has no objection to the delay of 5 days being condoned.
