Heard Mr. T. Tapak, learned counsel for the petitioner.

This is an application under Section 528 of the Bharatiya Nagarik Suraksha Sanhita(BNSS), 2023, praying for quashment of the F.I.R. dated 01.03.2026, being Tawang Police Station Case No. 05/2026, under Sections 196(1)/356(2) of the Bharatiya Nyaya Sanhita(BNS), 2023.

Issue notice, returnable by 3 (three) weeks.

As Mr. D. Loyi, learned Public Prosecutor, has entered appearance and

accepted notice on behalf of respondent Nos. 1 to 3, no formal notice is required to be issued to the said respondents.

The learned counsel for the petitioner shall take steps for service of notice upon respondent Nos. 4 to 22 by way of speed post as well as through the usual process within two working days.

List the matter **after 3 (three) weeks.**

Having considered the submission of learned counsel for the petitioner that the petitioner apprehends a threat to his life while appearing before the Investigating Officer at Tawang, it is directed that the concerned authorities shall take appropriate steps for providing security, in the event an imminent threat to the life of the petitioner is found, strictly in accordance with the applicable rules, guidelines and norms governing the grant of such protection. The petitioner may be permitted to appear before the Investigating Officer through virtual mode, as may be permissible under law.
