Heard Mr. Taying Nega, learned counsel for the petitioners and Mr. T. Tagum, learned Standing Counsel, Education Department representing all the respondents.

By filing this writ petition, the petitioners 15 (fifteen) in numbers have challenged the impugned order dated 06.02.2026 whereby the contractual services of the petitioners along with others have been terminated.

Issue notice, returnable by 3 (three) weeks.
