The learned counsel for the petitioners of all these matters are present.

2. The respondent authorities are represented by Mr. N. Ratan, learned Additional Advocate General for the State.

3. The learned Additional Advocate General by referring to the order dated 27.03.2025 has submitted that he was required to address the Court as to whether some of the writ petitions in this batch are not connected and whether they are required to segregated.

4. It is submitted that he has gone through the records and he has found that in so far as the writ petitions being WP(C) 305 (AP)/2019, WP(C) 328 (AP)2019, WP(C) 354 (AP)/2019, WP(C) 355 (AP)2019, WP(C) 356 (AP)/2019, WP(C) 385 (AP)2019, WP(C) 386 (AP)/2019, WP(C) 387 (AP)2019 and WP(C) 388 (AP)/2019 are concerned, those writ petitions are to challenge the Fact-Finding Committee and the consequent recovery notice issued, are also under challenge. Accordingly, it is submitted that these matters can be taken up together.

5. In respect of writ petitions being WP(C) 426 (AP)/2019 and WP(C) 336(AP)/2020, it is submitted that although these writ petitions are against the finding of the Fact-Finding Committee, but the land area is different from the above referred cases. Accordingly, it is submitted that these two matters be

taken up separately.

6. In respect of WP(C) 380 (AP)/2021, subject matter relates to the claim of damages caused during the construction of road. Accordingly, it is submitted that this matter be taken up separately.

7. In respect of writ petitions being WP(C) 68(AP)/2022, WP(C) 454 (AP)/2022, WP(C) 246 (AP)/2023, WP(C) 630 (AP)/2023, WP(C) 25 (AP)/2024, WP(C) 30 (AP)/2024, WP(C) 207 (AP)/2024 and WP(C) 466 (AP)/2024, it is submitted that these writ petition relates the claim of the petitioners for solatium. Accordingly, these matters be also taken up separately.

8. In respect of writ petitions being WP(C) 118 (AP)/2022, WP(C) 404 (AP)/2022 and WP(C) 401 (AP)/2024, it is submitted that these matters are unconnected and does not relate to the Fact-Finding Report or recovery of excess compensation allegedly disbursed. Accordingly, it is submitted that these writ petitions be taken up individually and separately.

9. The learned counsel appearing for the petitioners agreed to the submissions made by the learned Additional Advocate General.

10. Accordingly, writ petitions being WP(C) 305 (AP)/2019, WP(C) 328 (AP)/2019, WP(C) 354 (AP)/2019, WP(C) 355 (AP)/2019, WP(C) 356 (AP)/2019, WP(C) 385 (AP)/2019, WP(C) 386 (AP)/2019, WP(C) 387 (AP)/2019 and WP(C) 388 (AP)/2019 shall be clubbed together and shall be taken up as a batch and the other matters will also be grouped separately as indicated above and be listed separately, unconnected with these nine writ petitions.

11. List WP(C) 305 (AP)/2019, WP(C) 328 (AP)/2019, WP(C) 354 (AP)/2019,

WP(C) 355 (AP)2019, WP(C) 356 (AP)/2019, WP(C) 385 (AP)2019, WP(C) 386 (AP)/2019, WP(C) 387 (AP)2019 and WP(C) 388 (AP)/2019 again on 13.05.2025.

12. In so far as the unconnected matters are concerned, the Registry shall fix the matters after 3 (three) weeks on a date to be fixed by it.
