Heard Mr. T. Gyadi, learned counsel for the petitioners. Also heard Mr. N. Ratan, learned Additional Advocate General for the State respondents.

The petitioners are aggrieved that their promotion to the next higher post of Assistant Engineer have been given effect from 07.08.2024, although the they have been rendering services on *ad hoc* basis as Assistant Engineers for a long period.

It is the case of the petitioner that they have satisfied the requirement of the Department under the rules, having rendered 8(eight) years of service and having successfully cleared the departmental accounts examination as Junior Engineers. Being aggrieved, the present writ petition has been filed.

Issue notice, returnable in 4(four) weeks.

As Mr. Ratan, learned Addl. A.G. appears and accepts notice on behalf of respondents No.1, 2 and 3, issuance of formal notices is waived. However, requisite extra copies of the writ petition be furnished to him within a week from today.

The learned counsel for the petitioners shall take steps for service of

notice upon the respondents No.4 to 9 by registered post with A/d as well as by usual process, within a week from today.
