ORDER

Heard Mr. N. Rama, learned counsel for the petitioner.

2. The grievance of the petitioner is directed against the Notification, dated 07.08.2025, issued by the President, Arunachal Olympic Association(AOA), Naharlagun, whereby, while constituting the Adhoc Committee to review the constitution of Arunachal Body Building Association(ABBA) in alignment with the National Sports Federation(Indian Body Builders Federation), has directed to conduct the election of the Arunachal Body Building Association(ABBA) afresh through Special General Body Meeting or Annual General Meeting(SGM/AGM) by inviting observers from the National Federation within 3(three) months and submit the report and restraining any party from carrying-out activities in the name of Arunachal Body Building Association(ABBA) till a recognized State Body is duly constituted.

3. The petitioner contends that the Arunachal Body Building Association(ABBA) is an independent and has separate legal entity and is governed by its own constitution/bye-laws and the Arunachal Olympic Association(AOA) does not have the power and jurisdiction to interfere with internal election/selection process of the Arunachal Body Building Association(ABBA). And that the impugned Notification is in violation of the bye-laws of the Association.

4. The petitioner has further sought for an interim order staying the operation of the impugned Notification, dated 07.08.2025, issued by the President, Arunachal Olympic Association(AOA), Naharlagun.

5. Considering the submissions made by the learned counsel for the petitioner and upon perusal of the records, this Court is of the opinion that the matter requires further consideration.
6. In view of the above, issue notice to the respondents, returnable within 3 weeks.
7. Steps upon the respondents be taken by registered post with A/D as well as by usual process within a week from today.
8. List it after 3(three) weeks on a date to be fixed by the Registry.
9. The interim prayer shall be considered on appearance of the respondents.
