ORDER

Heard Mr. T. Jamoh, learned counsel for the petitioners.

Challenge made in this writ petition is to the notice dated 18.09.2025, issued by the Circle Officer-cum-Estate Officer, East Siang District, Pasighat, whereby, the petitioners were directed to vacate the Government land having been found encroached based on the order dated 22.08.2025, passed by the Deputy Commissioner.

Issue notice returnable by 4(four) weeks.

Since, Ms R. Basar, learned State counsel appears and accepts notice on behalf of all the respondents, no formal notice is required to be sent. However, requisite extra copies of the writ petition be furnished to her during the course of the day.

Considering that for initiation of the eviction process, notice is

required to be issued under Section 4 of the Arunachal Pradesh Public Premises (Eviction of Unauthorised Occupant) Act, 2003 and the impugned notice appears to have been issued under Section 5 of the said Act, till the returnable date, the impugned notice dated 18.09.2025, issued by the Circle Officer-cum-Estate Officer, East Siang District Pasighat, shall remain stayed.

List the matter again after 4(four) weeks.
