learned Advocate Mr. Premal S. Rachh appearing for the Respondent No.2 places on record the affidavit filed by the respondent – original complainant which is ordered to be taken on record.

This Court heard the learned Advocates appearing for the respective parties on the aspect of interim relief.

Upon perusal of the FIR, it appears that the dispute involved between the parties is purely of commercial nature. The incident alleged in the FIR has

taken place in the month of January 2023 for which the FIR came to be lodged in the month of December 2025. As per the case of prosecution, the first informant had paid the amount of Rs.1,14,00,000/- to the petitioner for purchase of certain goods. However, against the said amount of Rs.1,14,00,000/-, the petitioner herein had allegedly supplied goods worth Rs.40,42,000/- only and the remaining amount of Rs.73,57,910/- has either not been repaid by the petitioner nor any goods supplied to him. Upon perusal of the record, it appears that the petitioner had also issued post dated cheques towards the amount in question. The record also indicates that the Investigating agency has acted highhandedly against the petitioner.

Having regard to the same, there shall be Ad-interim relief in terms of Para-11(B) till the next date of hearing.
