ORAL ORDER**(PER : HONOURABLE MS. JUSTICE BELA M. TRIVEDI)**

1. After hearing the concerned learned Advocates for the parties and perusing the directions issued by the Court vide Orders dated 15.12.2020 and 26.2.2021, it appears that the concerned respondents have not complied with or have partially complied with the said directions issued by the Court.
