1. Learned Advocate Ms. Paurami Sheth for the Plaintiff has tendered purshish dated 25.06.2026 and submitted that the Plaintiff had sorted out the issue with the Disponent Owners of the Defendant No. 1 Vessel outside this Court directly, that as agreed between the parties, Disponent Owner has remitted the agreed amount of USD 210,000/- to the Plaintiff towards full and final settlement of its claim and hence the Plaintiff does not want to proceed further with the captioned suit and prayed for vacating arrest order dated 22.06.2026 forthwith and incidental directions. The said purshish is taken on record and forms part of this order.

2. Heard Learned Advocate Ms. Paurami Sheth for the Plaintiff.

3. In view of the purshish filed by the Plaintiff, the captioned suit is disposed of as withdrawn unconditionally without an effective hearing. The Order dated 22.06.2026 is vacated, and the Defendant Vessel is released with immediate effect and further permitted to sail.

4. The Registry is directed to issue Release Warrant forthwith.

5. The Registry is further directed to communicate this Order to Port and Customs authorities at Dahej Port at the following addresses, and the Authorities at Dahej Port shall act on an Email copy of the order and release the Defendant Vessel forthwith and permit her to sail out of Dahej Port.
