ORAL ORDER

1. Heard learned Advocate Ms. Krishna S. Shah on behalf of learned Advocate Mr. S. P. Majmudar appearing for the Petitioner No. 1.
2. Perused the withdrawal of appearance note dated 30.06.2026 filed by learned advocate Mr. S. P. Majmudar addressed to the office and perused the office note dated 03.07.2026 pertaining to the same.
3. The learned advocate for the Petitioner No. 1 has filed the withdrawal of appearance note for deleting the name of learned Advocate Ms. Sejal K. Mandavia for the Respondent No. 2 from the cause title of the captioned
