1. Present Petition is preferred by the Petitioners (Original Accused), under Section 528 of the Bharatiya Nagarik Suraksha Sanhita, seeking quashing of FIR CR No. 11211057260730 of 2026 registered with Surendranagar City 'A' Division Police Station, District: Surendranagar, for the offences punishable under Sections 117(2), 115(2), 352, 351(3) and 54 of the Bharatiya Nyaya Sanhita, 2023 and under Section 135 of the Gujarat Police Act.

2. Heard learned Advocate for the Petitioners and learned APP for the Respondent – State. Learned Advocate, Mr. Satyajit Songara, appears and states that he has received instructions to appear on behalf of Respondent No.2 – Original Complainant and he would be filing his appearance during the course of the day. Registry to accept the Vakalatnama.

3. Rule. Learned APP waives service of notice for and on behalf of the respondent – State and learned Advocate Mr. Songara waives service of Rule on behalf of the Original Complainant.

4. Learned Advocate for the Petitioners has submitted that the matter has been amicably settled between the parties and they are now not willing to proceed with the complaint any further.

5. Leaned Advocate appearing on behalf Original Complainant – Prayagdas Vanmalidas Dangar, has placed on record the Affidavit dated 08.07.2026. He submitted that matter has been amicably settled between the parties and there is no objection if present Petition is allowed. The relevant paragraph from the Affidavit reads thus:

“3. I say and submit that in view of the settlement arrived at between the present deponent and applicants, it is submitted that I have no objection if the FIR being CR No. 11211057260730 of 2026 registered with Surendranagar City A Division Police Station, Surendranagar as well as all further proceedings arising out of the said FIR the applicants is quashed and set aside.”

6. Considering averments made in the Affidavit as also

the submissions made by the learned Advocates for the respective parties, the present Application deserves to be allowed and is hereby allowed. The F.I.R. CR No. 11211057260730 of 2026 registered with Surendranagar City 'A' Division Police Station, District: Surendranagar, and all other consequential proceedings are hereby quashed and set aside qua the present Petitioners. Rule is made absolute.
