Heard Ms. Urja Dave, learned advocate for the petitioner in all the matters and Mr. Anantanand J. Singh, learned advocate for respondent no.1 in Special Civil Application No.13114 of 2020, Special Civil Application No.13131 of 2020, and Special Civil Application No.13117 of 2020.

Ms. Urja Dave, learned advocate submits that all seven
