We have heard Shri Mihir Thakore, learned Senior Advocate appearing for Nanavati Associates for the petitioners in Special Civil Application no.5818 of 2021, Shri Amit Manilal Panchal, the party-in-person in Civil Application no.5 of 2021 in Writ Petition (PIL) No.118 of 2020, Shri Kamal Trivedi, learned Advocate General along with Ms. Manisha Lavkumar, learned Government Pleader and Shri Chintan Dave, learned AGP for the State as also Shri Satyam Y. Chhaya, learned counsel appearing for the Ahmedabad Municipal Corporation.
