**COMMON ORAL ORDER
(PER : HONOURABLE THE CHIEF JUSTICE MR. JUSTICE ARAVIND KUMAR)**

1. During the course of hearing, we have noticed that in this proceedings, in various pleadings put forthwith by the writ petitioner (Shri Vishwas Sudhanshu Bhamburkar) he has made certain averments. The language employed thereunder is not only unparliamentary but also which ought not to be used in the pleadings. Though we intended to extract the said specific pleadings as stated in the additional affidavit dated 4.11.2022 filed in WP (PIL) No.63 of 2019 and as stated in F/Letters Patent Appeal No.23119 of 2022, we desist from extracting the same, particularly while party appearing in person has made a categorical statement that he would withdraw all such averments and undertakes to file an affidavit. He has also submitted that he would withdraw all such allegations made in various pleadings by tendering unconditional apology and state such plea was raised in his exuberance of exposing public cause as espoused in WP(PIL)

No.63 of 2019. His submission and undertaking is placed on record.

2. Only on such affidavit being filed, this Court would take up the matter for further hearing though this matter was heard today extensively from 12.40 pm to 1.45 pm. and from 2.35 to 3.55 pm.

3. The arguments was led by senior counsels Shriyuths Mihir Thakore and Mihir Joshi appearing for the writ applicants in Special Civil Application Nos.13278 of 2021, 14476 of 2021 and 13196 of 2021 respectively along with connected interlocutory applications filed in said proceedings. We have also heard partly Shri Vishwas Sudhanshu Bhamburkar party appearing in person.

4. Interim orders made earlier to continue till next date of hearing.
