ORDER

[1.0] RULE. Learned APP waives service of rule for the respondent-State.

[2.0] The present application is filed under Section 483 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (for short "BNSS") for regular bail in connection with **FIR being C.R. No. 11204046260404 of 2026 registered with Nadiad Town Police Station, Kheda** for offences punishable under Sections 310(2), 189(2), 191(2), 190 115(2), 352 and 351(3) of the Bhartiya Nyaya Shanhita 2023 and Section 135 of the GP Act.

[3.0] Learned advocate appearing on behalf of the applicant submits that applicant is innocent and has been falsely implicated in the offence and now nothing is required to be recovered or discovered. He therefore submits that, considering the nature of the offence, the applicant may be enlarged on regular bail by imposing suitable conditions.

[4.0] Learned APP appearing on behalf of the respondent-State and learned advocate appearing on behalf of the original Complainant have vehemently opposed the present application on the ground that the accused persons having past antecedents and requested to dismiss the present application for regular bail looking to the nature and gravity of the offence.

[5.0] While granting bail, the Court has to consider the involvement of the accused in the alleged offence, the jurisdiction to grant bail has to be

exercised on the basis of the well settled principles having regard to the facts and circumstances of each case and the following factors are to be taken into consideration while considering an application for bail: (i) the nature of accusation and the severity of the punishment and the nature of the materials relied upon by the prosecution; (ii) reasonable apprehension of tampering with the witnesses and threat to the complainant or the witnesses; (iii) reasonable possibility of securing the presence of the accused at the time of trial or the likelihood of his abscondence; (iv) character behaviour and standing of the accused and the circumstances which are peculiar to the accused; (v) larger interest of the public or the State and similar other considerations are required to be considered.

[6.0] I have heard the learned advocates appearing on behalf of the respective parties and perused the investigation papers. Following aspects have been considered:

- (1) substantial part of investigation is over;
- (2) None of the offence alleged is punishable with life sentence or death penalty and is triable by the Court of Magistrate;
- (3) Applicant is behind the bars since 16.06.2026;
- (4) There is nothing to be recovered or discovered from the applicant;
- (5) Obviously commencement and conclusion of trial will take some time;
- (6) The applicant is having three past antecedents; in one of them, he has been convicted under Section 323 of the BNS. Considering the nature of the allegations and the role attributed to the present applicant in the impugned offence, the present application deserves consideration.
- (7) As per the allegations levelled against the present applicant

and the complainant, it appears that the accused persons, with a common object, formed an unlawful assembly and went to the complainant, keeping a grudge arising out of the election, as the complainant had played an active role in defeating the accused persons. Accused No. 2 assaulted the complainant by means of a wooden log, while the other co-accused assaulted him by giving kick and fist blows. In this regard, the complaint came to be registered.

Considering the nature of the injuries and the allegations, the present application deserves consideration since a limited role is attributed to the present applicant;

(8) Considering the aforesaid facts, there are no circumstances to indicate that the continued incarceration or detention of the present applicant is necessary.

[7.0] This Court has also taken into consideration the law laid down by the Hon'ble Apex Court in the case of **Sanjay Chandra vs. Central Bureau of Investigation** reported in **[2012]1 SCC 40** as well as in the case of **Gudikanti Narasimhulu And Ors vs. Public Prosecutor, High Court of Andhra Pradesh reported in (1978)1 SCC 240**. Obviously, the conclusion of trial will take time and keeping the accused behind the bars is nothing but amounts to pre-trial conviction and therefore, considering the celebrated principle of bail jurisprudence is that "bail is a rule and jail is exception" as well as the concept of personal liberty guaranteed under Article 21 of the Constitution of India, present application deserves consideration.

[8.0] In the facts and circumstances of the case and considering the nature of the allegations made against the applicant in the FIR, without discussing the evidence in detail, prima facie, this Court is of the opinion that this is a fit case to exercise the discretion and enlarge the applicant on regular bail. Hence, the present application is allowed. The applicant is ordered to be released on regular bail in connection with **FIR being C.R. No. 11204046260404 of 2026 registered with Nadiad Town Police Station,**

Kheda on executing a personal bond of Rs.25,000/- (Rupees Twenty-five Thousand only) with one surety of the like amount to the satisfaction of the trial Court and subject to the conditions that he shall;

- (a) not take undue advantage of liberty or misuse liberty;
- (b) not act in a manner injurious to the interest of the prosecution & shall not obstruct or hamper the police investigation and shall not to play mischief with the evidence collected or yet to be collected by the police;
- (c) surrender passport, if any, to the Trial Court within a week;
- (d) not leave the State of Gujarat without prior permission of the Trial Court concerned;
- (e) mark presence before the concerned Police Station once a month till filing of the charge-sheet between 11.00 a.m. and 2.00 p.m.;
- (f) furnish the UIDAI Number, Contact Number/s, Passport Number (if he is having the passport), E-mail address and present address of his residence to the Investigating Officer and also to the Court at the time of execution of the bond and shall not change the residence/contact number without prior permission of Trial Court;*
- (g) not enter Nadiad Town till filing of the charge-sheet, except for marking presence and / or attending the court proceedings;*

[9.0] The authorities will release the applicant only if he is not required in connection with any other offence for the time being. If breach of any of the above conditions is committed, the Sessions Judge concerned will be free to issue warrant or take appropriate action in the matter.

[10.0] Bail bond to be executed before the lower Court having jurisdiction to try the case. It will be open for the concerned Court to delete, modify and/or relax any of the above conditions, in accordance with law.

[11.0] At the trial, the trial Court shall not be influenced by the observations of preliminary nature qua the evidence at this stage made by this Court while enlarging the applicant on bail.

[12.0] Rule is made absolute to the aforesaid extent. Direct service is permitted.
