ORAL ORDER

(PER : HONOURABLE MR. JUSTICE UMESH A. TRIVEDI)

A request on behalf of Ms. Manisha Lavkumar, learned Additional Advocate General is made for adjournment in this case on the ground that she is before Hon'ble Supreme Court. This group of matters was specifically kept today for the purpose of hearing. However, since review applications are filed in the petitions where orders are passed and present contempt applications are preferred as also against an order condoning delay in one of the review applications, is already challenged before the Hon'ble Supreme Court, wherein review proceedings thereof, are stayed by the Court.

Be that as it may, the respondents herein are directed to calculate

and keep ready the funds as if the applicants are entitled to, as held in the main petitions / LPAs / SLPs, for the payment to them, if challenge by the State Government by way of any review application or any SLP before the Supreme Court, fails, so as to pay it on the next date of said order. At the same time, one of the matters before the Supreme Court, wherein review proceedings before this Court, are stayed, is coming up on 02.12.2024 as also since learned Additional Advocate General is not here and there is a request for time, stand over to **6th December 2024.**

In other matters also, as stated on behalf of the State Government that review applications are filed along with delay condonation applications as well, long back, but they are yet not circulated, the State Government to expedite the steps so that this contempt applications, though not required to be kept pending awaiting the decision thereon, with a view to give one chance to the State Government, it is hereby adjourned. However, that will not absolve the State Government from taking steps to see that those review proceedings are disposed of as early as possible.
