ORAL ORDER

1. Heard learned Advocate Ms. Riya P. Navin appearing for the Applicant Nos. 1 to 4.
2. Perused the withdrawal of appearance note dated 16.12.2025 filed by learned advocate Ms. Riya P. Navin addressed to the office. Perused the office note dated 17.12.2025 pertaining to the same.
3. The learned advocate Ms. Riya P.
