ORAL ORDER

1. Learned senior advocate Mr.K.M.Patel submits that

though no dispute was raised with regard to the wages for the period of strike, learned Deputy Labour Commissioner has referred to the learned tribunal and directed to decide the same. Learned senior advocate Mr.K.M.Patel submits that said order was subject matter of challenge in SCA No.9746 of 2025. Learned senior advocate Mr.K.M.Patel submits that during the pendency of the petition actions were taken dismissing the present respondent and for that application under section 33(2)(b) came to be filed seeking approval of the dismissal. Learned senior advocate Mr.K.M.Patel submits that preliminary objections were taken of the respondent stating that this would fall under section 33(1)(b) and not under section 33(2)(b) and therefore, the application was sought to be rejected which was allowed by learned labour court by passing order on 13.09.2022.

2. Learned senior advocate Mr.K.M.Patel submits that unless and until decision is taken in writ petition being SCA No. 9746 of 2025 it cannot be said that dispute is connected with the reference which was pending for adjudication.

3. In view of the above submissions, let notice be issued making it returnable on 01.12.2025.
4. Ad-interim relief in terms of para 6(b) is granted till the next date of hearing.
5. To be heard together.
