1. The corpus has remained present from Nari Sanrakshan Kendra, Anand. We have heard her in the Chamber. The respondent No.4-father is also present alongwith his advocate Mr. Ankit Y. Bachani.
2. The corpus has stated that all her documents, i.e. Aadhar Card, Marksheet of Standard X and XII, the original Birth and Leaving Certificate are lying at her parents / grandparent's house. The corpus has stated of her desire to study further and hence, she is in need of her original documents.

3. The respondent No.4-father has denied of such documents lying in the house.
4. In that circumstances, respecting the desire of the corpus, we direct the Police Inspector, Vasad - Shri. K.A. Patel to accompany the corpus to the house of respondent No.4 / the grandparent's house, with all protection, to enable the corpus to collect her documents on **SEPTEMBER 14, 2026** with prior intimation to Nari Sanrakshan Kendra, Anand. The Police Inspector is directed to draw panchnama of the original documents taken in possession by the corpus from her father / grand parent's house and a copy of the same be given to the father. The panchnama of handing over the documents to the corpus be undertaken on **SEPTEMBER 14, 2026**. In the meantime, the corpus would stay at the Nari Sanrakshan Kendra, Anand.
5. Let the matter be listed on **SEPTEMBER 24, 2026**. In the meantime, the arrangement made vide order dated 02.09.2026 to continue.
6. A copy of this order be handed over to the learned Additional Public Prosecutor.
